







CALL FOR EXPRESSION OF INTEREST

For Purchase of Laboratory Equipment, Glassware & Chemicals

The International Center for High Education on Mediterranean Agronomy (CIHEAM-Bari) invites interested firms and qualified dealers to submit their expression of interest for providing high quality laboratory equipment, glassware and chemicals.

General project information:

Project: OliveCulture scale-up [see the link: Olive Culture | Farm to Fork]

Donor: Italian Agency for Cooperation and Development (AICS)

Overall project objective: To enhance capacities of the Federal Government and the suitable Provinces in assisting rural communities and private sector. This will involve modernizing testing capabilities for olive culture strengthening phytosanitary facilities to effectively manage pests and diseases. Among other measures the selected laboratories in Islamabad, Punjab, KPK and Balochistan will be upgraded, ensuring that these facilities have the potential to significantly support the olive chain value.

Objective of this call for proposal:

This call for proposal invites applicants to describe their capacity to supply the items specified in Table 1,
2, 3 granting the required specifications -including the qualified technical assistance- and present proof of the requirements listed in ANNEX A to be eligible.

Based on the received proposals, CIHEAM will evaluate the consistency of each applicant according to the criteria as per **ANNEX B** including the quotation of the items and launch specific procurement processes based on this **market analysis**.

GENERAL INSTRUCTIONS

The below requirements detail how bids are to be submitted and reviewed for the above-mentioned project. Please read and follow these instructions carefully:

- All companies interested in applying to this call are recommended to send a mail to info@oliveculture.org including all contacts of the company to be registered in the <u>list of</u> potential applicants which will be kept constantly informed by the project. - 2) Deadline: No later than April 14th, 2025, H13:00
- 3) All official correspondence during the bidding process must be done in English.
- All queries are accepted by mail (<u>info@oliveculture.org</u>) by 25th March 2025. All clarifications will be provided to all registered potential applicants by 29th March 2025.
- 5) All deadlines and dates mentioned in this invitation for submission of bids must be adhered to. Bids received beyond the deadline will not be considered.
- 6) Applicants can express interest for all listed material or part of it.
- 7) All application should contain all fields filled signed and stamped Annex A,B,C.
- 8) Companies must fill their interested part of the fields in **Table 1,2,3** (It is admitted to offer all or part of equipment/material listed in the **TABLES**.
- 9) The estimated quantities are indicative of the 3 years **potential needs** of the project. No contracts will be awarded through this call which is intended as **market analysis exercise**.
- 10) The prices to quote by companies must include delivery and installation of equipment in each province laboratories with validity 12 months.
- 11) All proposals must be submitted by mail to <u>info@oliveculture.org</u> indicating the subject: **APPLICATION TO EXPRESSION OF INTEREST** and company contacts.

EVALUATION CRITERIA

The evaluation report will include a classification of the **eligible companies and their capacity** to supply specific equipment, material and consumables according to the score system described in ANNEX B.

The **DATABASE** desumed from this call will be the basic tool to select appropriate companies to bid in the particular purchasing processes along the implementation of OliveCulture scale-up Project (2024-2027).
