## Federal govt, provinces should review respective clauses in Minerals Act: SC

ISLAMABAD, Nov 21 (NNI): The Supreme Court of Pakistan while hearing the presidential reference on the Reko Diq project has directed that the federal government and the provinces should review their respective clauses in the minerals act.

A five-member larger bench of the apex court led by Chief Justice Umar Ata Bandial heard the refer-

ence on Monday.

President Arif Alvi, on the advice of Prime Minister Shehbaz
Sharif, had filed the reference to seeking the apex court's opinion on the Reko Diq out-of-court settlement deal.

During the hearing, a friend of the court, advocate Salman Akram Raja told the court that there are two types of minerals laws federal and provincial. "The Minerals Act 1947 is both federal and provincial in nature, he said, adding that the proposed amendment to the Minerals Act, 1947 is contrary to the scheme given in
